

31st COSCAP-SA STEERING COMMITTEE MEETING

PROGRAMME BUDGET AND FUNDING – 2023 AND PHASE VI Discussion Paper 5 (DP-5)

(Presented by ICAO)

This Discussion Paper presents the status of the COSCAP-SA Trust Fund and the Phase VI Programme budget based on the funds available as of 31 December 2023.

1.0 Background

COSCAP

South Asia

- 1.1 Article III, Paragraph 3.3 of the Memorandum of Understanding (MoU) signed by Member States stipulates that the COSCAP-SA Programme shall be funded primarily by the Member States through annual contributions in accordance with a cost-sharing formula which is approved by the Steering Committee.
- 1.2 Article III, Paragraph 3.4 of the MoU provides for the mobilization of grant funds from the donor community to supplement the Programme funds.
- 1.3 Article III, Paragraph 3.6 of the MoU stipulates that the Member States' annual contributions which is supplemented by donor-provided funds as may be available, shall constitute the general pool of the COSCAP-SA Trust Funds to be maintained by ICAO. The moneys from the Trust Fund shall be used for common benefits, functions and activities defined in Article II, Paragraph 2.1.1 of the MoU.
- 1.4 All Member States signed the Programme Document for the Phase V which was implemented from 2019 to 2023.
- 1.5 The Programme transitioned to Phase VI for a five your period from 1 January 2024 to 31 December 2028. The associated Programme Document describes the nature and scope of the activities intended to be performed by the COSCAP-South Asia during its Phase VI together with the resources required to perform such activities. Two Member States of the seven who participate in Phase VI have signed the Programme Document to date.
- 1.6 Pursuant to Article IV, Paragraph 4.1 of the MoU, ICAO shall provide the services specified in the Programme Document in accordance with the established ICAO rules, policies, procedures and practices.



- 1.7 Article VII, Paragraph 7.4 of the MoU describes the duties and functions of the Steering Committee which include inter alia, the following:
 - a) Monitor and evaluate the Programme activities since the previous meeting;
 - b) Formulate policies and assign priorities for the activities of COSCAP-SA, taking into account the requirements of the MOU, and the provisions in the current phase of the COSCAP SA Programme Document and the availability of funds;
 - c) Review and approve the annual work programme and budget of COSCAP-SA.

The total financial contribution expected from the Member States for Phase VI is USD 3,130,407.



- 2.4 Appendices I A and I B provide details on the use of specific-purpose funds received by the Programme from Airbus and The Boeing Company respectively.
- 2.5 The Airbus and The Boeing Company contributions are tied to specific activities agreed to between Airbus and The Boeing Company, and the Programme.

3.0 Budget

South Asia

- 3.1 Appendix II A outlines the budget based on Programme Document of Phase VI, which will permit the operation of the Programme until the last quarter of 2028 with the budgeted staffing, which has been maintained similar to Phase V (i.e. CTA/PC - 12 months per year, ANS expert -6 months per year and AGA expert -4 months per year). The Phase VI budget has been calculated at USD 4,174,500.
- 3.2 Normally Regional Programmes should have sufficient funding to allow Programme operation for a rolling 12-month period to allow for contract extension of staff and necessary contracts for utilities and yearly/monthly miscellaneous expenses.
- 3.3 The budget does not include uncommitted specific-purpose funds kindly contributed by Airbus and The Boeing Company. Approved Donor expenditures are included in the record of actual expenses and contributions.
- 3.4 Appendix II B provides the Statement of Estimated Fund Balance as at 31 December 2023 (report for balance as at 31 March 2024 will be available in May 2024). The estimated funds available including future commitments beyond 2023 is USD 1,033,128.
- 3.5 Funding must be available in the trust fund before ICAO can make any contractual commitments. In order for the Programme to remain operational, it is important for Members to ensure payment of their annual contributions. This, in turn, will encourage donors to maintain their contributions, enabling the Programme to continue making a positive impact on safety oversight in the sub-region. It is therefore important that Members make timely payments, as has been happening most of the time.
- 3.6 As requested by the Programme, two budget scenarios have been provided as follows, in addition to the budget of Phase VI as described in above paragraph 3.1.
 - a) Appendix II C to employ an ANS expert for 9 months per year and an AGA expert for 6 months per year during the cycle of Phase VI. This budget is estimated at USD 4,423,700.
 - b) Appendix II D to employ an ANS expert for 12 months per year and an AGA expert for 12 months per year during the cycle of Phase VI. This budget is estimated at USD 5,001,200.



4.0 Action by the Steering Committee:

COSCAP

- 4.1 The Steering Committee is invited to note of the discussion paper.
- 4.2 Discuss as appropriate, the budget scenarios presented in paragraph 3.6 above.

4.3 Programme Members are encouraged to make their respective annual fund contributions in time.

4.4 Encourage Donors and Safety Partners to continue their contributions to COSCAP-SA, as these are vital to the successful implementation of the Annual Work Programme.
